

ASC Enforcement in iQIES

Managing an Enforcement

To add a new enforcement, the following conditions must be met:

1. A certified provider
2. Health survey with deficiencies with locked citations
3. Health survey has not been added to a different enforcement, i.e. only one survey can be designated as the starting survey

Starting Survey - The survey used to create an enforcement case is referred to as the starting survey, and its exit date is the start of the enforcement cycle

Additional Information

1. Health Surveys only
2. Contact the iQIES Service Center to delete an enforcement in iQIES.
3. The letter that follows the Enforcement-ID shows whether the enforcement is a federal (F) or state (S) enforcement.
